Since the introduction of the first vaccine mandate and associated shutdowns in August 2021, OneChiropractic has faced significant challenges that impacted our contributor numbers. Despite these hurdles, we achieved a 100% success rate in all seven mandated states by November 2021, ensuring that our practices remained open without incurring fines or shutdowns. This achievement was followed by strategic expansions, with deployments to Australia, New Zealand in December 2021, and Canada in January 2022, where we also took on a significant portion of the legal expenses faced by the local chiropractic community.

By January 2022, our efforts had rallied 4000 contributors, but the ongoing battles against mandates throughout 2022 and marketing censorship issues in 2023—which resulted in 26 legal victories—placed a strain on our resources and support base. This series of challenges, combined with the evolving healthcare landscape, led to a decline in our contributor count to 2200 by early 2024, despite a significant policy win in February 2024 that lifted restrictions on treating pediatric patients under the age of two.

These fluctuations in our supporter base underscore the critical need for continued advocacy and the importance of community engagement to navigate and overcome regulatory challenges effectively. As we move forward, reinforcing our contributor network will be essential to sustain and advance our mission of protecting and promoting chiropractic care globally.





FUNDING IMPACT

OneChiropractic has successfully managed legal challenges facing the profession, winning all cases in 2021 and 2022. However, financial constraints in 2023 and 2024 forced us to decline 150 and 56 cases, respectively. This underscores the urgent need for increased funding to continue our robust defense of chiropractic practitioners worldwide.

Advocating for Chiropractic Excellence in the USA

Legislative Achievements

Chiropractic Pilot Project Initiative

- Proposal and Approval: Introduced proposed language to the National Defense Authorization Act (NDAA) to initiate a Chiropractic Pilot Project aimed at enhancing the wellness of military personnel. This initiative successfully passed in the House of Representatives, reflecting significant legislative support.
- Senate Update: Despite strong advocacy efforts, the proposal was withdrawn during Senate reviews. Plans for revisiting this initiative are underway, with strategies being developed to ensure future success.

Legal Advocacy

Class Action Against Insurance Claw Backs

 Action Initiated: Launched preparations for a class action lawsuit targeting unjust claw back practices by insurance companies. This pivotal legal move aims to defend fair treatment and reimbursement practices for chiropractic services, setting a precedent for nationwide policy.

Standardization Efforts

Uniformity in Animal Chiropractic Care

Language Standardization: Spearheaded efforts to standardize terminology and practices for animal chiropractic care across the United States. This initiative promises to enhance regulatory clarity and professional consistency in this growing field.

Collaborative Development | Strengthening Professional Ties

- New Partnerships: Engaged in strategic meetings with key organizations to foster collaboration and unify efforts within the chiropractic profession. Notable collaborations include:
 - Foundation for Chiropractic Progress
 - The Chiropractic Summit
 - The Federation of Chiropractic Licensing Boards
 - The Chiropractic Strategic Plan
 - Community Engagement
 - National Presence
- Events and Representation: Participated in numerous events across the country, enhancing OneChiropractic's visibility and influence. These engagements provided valuable opportunities for advocacy, professional networking, and public education about the benefits of chiropractic care.

CANADA



Promoting Chiropractic Integrity and Advocacy Across Canada

Challenging X-Ray Policy

 Conflict with Regulatory Body: Engaged in a dispute with the Chiropractic College of British Columbia regarding a contentious x-ray policy deemed not in the best interest of patients and practitioners. Efforts are ongoing to revise this policy to better align with evidence-based practices.

Opposition to Bill 36

 Legislative Resistance: Actively opposed the language of Bill 36 in British Columbia, which threatened to diminish providers' rights. Through strategic lobbying and public engagement, we are working to safeguard these rights against restrictive legislative changes.

Legal Advocacy

Ontario Regulatory Overreach

 Extended Legal Battle: Faced a prolonged legal conflict with the Chiropractic College of Ontario concerning issues of regulatory overreach. This significant legal effort aims to balance regulatory authority with the practical realities of chiropractic practice.

Victory in Alberta

 Certification Responsibility: Successfully resolved a dispute with the Alberta College regarding their obligations to certify chiropractic equipment. This victory ensures better support for chiropractors in meeting compliance standards.

National Engagement Canada-Wide Presence

 Events and Representation: Maintained a robust presence at various events throughout Canada, enhancing the council's visibility and influence. These engagements have been crucial in spreading awareness, fostering professional connections, and advocating for the chiropractic community's interests.

AUSTRALIA



Strengthening Chiropractic Practice and Advocacy in Australia

Policy Reformation

Pediatric Adjustment Policy Change

Policy Impact: Successfully influenced the chiropractic board to amend
the pediatric policy by removing the restrictive "2 and under" clause,
which limited high amplitude low velocity adjustments for children aged
two and under. This change was achieved through collaborative efforts
with multiple organizations within Australia, enhancing the practice
scope for pediatric care.

Legal Successes

Defense Against AHPRA Complaints

 Case Victories: Defended and won over 25 cases involving unjust complaints filed by AHPRA, primarily concerning advertising practices.
 These successes have significantly aided chiropractors in maintaining their professional standing and marketing freedoms.

Operation Free Speech

Initiative Launch: Introduced "Operation Free Speech" to counteract
pervasive censorship issues and empower chiropractors to share their
expertise and experiences without fear of regulatory repercussions.
This campaign includes distributing materials and resources in
collaboration with various partners to bolster the community's
confidence in their public and professional expressions.

Restraint of Trade Legal Action

Government Lawsuit: Initiated steps to bring a restraint of trade lawsuit
against the Australian government. This action is prompted by what are
seen as unjustified policies and recommendations by AHPRA and Safer
Care Victoria, aiming to protect chiropractic practice rights against
governmental overreach.

Defense of Unvaccinated Chiropractor

Notable Legal Victory: Achieved a significant win in defending an
unvaccinated chiropractor who was targeted by governmental actions.
This case, which extended over a year, highlighted our commitment to
defending the legal rights and professional autonomy of chiropractors
under challenging circumstance.

Community Engagement

Engagement and Outreach

Australian Visits: Visited Australia twice to conduct townhalls and speak
at various events across the country. These visits have been crucial for
engaging with the chiropractic community, discussing current issues, and
strategizing on future advocacy efforts.

Legal Advocacy

Defense of Unvaccinated Chiropractors

 Ongoing Cases: Continued to represent five chiropractors facing challenges due to their non-vaccinated status amid the pandemic. Successfully defended two of these cases, with three still actively contested. These efforts underscore our commitment to supporting chiropractic professionals through complex legal and regulatory landscapes.

Initiatives

Operation Free Speech

 Campaign Expansion: Extended the "Operation Free Speech" initiative to New Zealand, aiming to dismantle censorship barriers and empower chiropractors to communicate openly about their practices and beliefs. This movement seeks to reinforce the profession's autonomy and public engagement.

Collaborative Efforts

Strengthening Defense Mechanisms

 Partnership with National Association: Collaborated with the national chiropractic association in New Zealand to develop a more unified and effective defense system for chiropractors. This strategic alliance enhances support structures and advocacy resources available to the chiropractic community.

Community Engagement

Outreach and Education

 Town Hall Meetings: Conducted multiple town hall meetings across New Zealand, providing a platform for discussion, education, and strategic planning. These visits have been pivotal in strengthening community ties and addressing pressing issues directly with practitioners and stakeholders.
